## **21st Annual General Meeting of Amcham**

Amcham organized its 21st Annual General Meeting on April 30, 2013 at Hotel ITC Maurya, New Delhi.

A Panel Discussion was organized on 'Role of Innovation and Technology in an Emerging Economy' where Nobel Laureate Dr. R.K. Pachauri, Director General, TERI was the Chief Guest. Dr. Pachauri spoke about the need for technology and innovation in a developing economy like India which would impact the society. He called for technology and innovation that could sustain the eco systems. Of particular significance were the technologies used in the building, transportation and agriculture sectors.

Mr. Venkatesh Valluri, Chairman of Ingersoll Rand India, moderated the discussion. He said that innovation was a necessity to improve the standards of living of society.

Addressing the participants during the Luncheon Session, U.S. Ambassador Nancy Powell dwelt on Indo-U.S. business relations.

Dr. Raghuram G. Rajan, Chief Economic Adviser to the Government of India, in his Keynote Address delivered at the Luncheon Session, said that the Government had made efforts to reduce the capital account deficit and was moving ahead to control the inflation, particularly the food inflation.

Earlier, Mr. Raj Jain, President of Walmart India and outgoing Chairman of Amcham, said "What we need is a climate of certainty where models of taxation and business are not too volatile for investor comfort. The uneven approach on taxation of transfer pricing cases is putting off some of the large investors as it undercuts their need for clarity, consistency and predictability in the investment climate."

Mr. Jain further said "It is time that the FDI sectoral caps are looked afresh as these caps have become irrelevant given the changed global economic situation. It would do well to consider increasing FDI in telecom and defense production to 100 per cent and bring about liberalization in the insurance and financial sectors at the earliest."

## India Tax – From Books to the Board Room

The tax environment in India has witnessed a series of developments in the past couple of years that have created doubts in the minds of investors and raised apprehensions on the certainty of tax laws in India. The Indian tax regime is increasingly being viewed as complex, uncertain and challenging which has perhaps significantly impaired India's image as a friendly investment destination.

This 'not so positive' view started to build up essentially with the retrospective tax amendments legislated last year. widening of the definition of royalties in the Indian tax laws was not helpful either.

The other major area of concern were the General Anti-Avoidance Rules ("GAAR") introduced by the erstwhile Finance Minister. The initial rules were seen as being draconian and not allowing fair opportunity to corporates to plan their businesses. Also, the much promised tax reforms in the form of Direct taxes Code Bill ("DTC") and Goods and Services Tax ("GST") were not put into place, though several rounds of discussions were held.

To add to the woes of foreign investors, in the recent months, highly aggressive and adverse transfer pricing audits have been imposed on multinational companies. The past few months have seen a series of adjustments ranging from USD 30 million

to USD 3,000 million. This has firmly put tax as on the CEO's agenda! A closer look at some of the transfer pricing cases suggests a deviation from the fundamental principles of taxation, including attempts to tax capital investments.

Uncertainty in tax treatment of transactions brings with itself prolonged litigation. It is a

well-known fact that in India, tax litigation on matters reaching the Supreme Court could take

15-20 years to attain finality.

The silver lining perhaps comes in the shape of the recently introduced Advance Pricing Agreements ("APA") mechanism, which has provided an opportunity to the taxpayer to agree pricing upfront with the tax authorities. It is indeed a welcome move and will go a long way in reducing litigation in transfer pricing matters. Another positive move granting an opportunity to the taxpayers to seek immunity from penalty is the service tax "amnesty scheme" announced by the Finance Minister while presenting the Union Budget 2013.

We also get comfort from the statements made by our Hon'ble Finance Minister in his Union Budget 2013 speech:

"India, at the present juncture, does not have the choice between welcoming and spurning foreign investment; it is an imperative."

"Clarity in tax laws, a stable tax regime, a non-adversarial tax administration, a fair mechanism for dispute resolution, and an independent judiciary will provide great assurance."

In the wake of these challenges, the corporate community often requires an organized forum to initiate and engage in a dialogue with the concerned authorities. Recognizing these needs, Amcham's Tax, Tariff & Regulatory Affairs Committee is devoted to taking the concerns of its members to the regulators/ authorities. Our continued attempt has been to provide corporate members a platform to voice their concerns on tax policies and share best practices.

The Committee has, in the recent past, organized various events across locations and represented the corporate community on matters of key interest, for instance indirect transfers, GAAR, service tax etc. Our focus has always been on building a wide range of relationships to take forward and address the concerns of the corporate fraternity. We welcome suggestions and inputs from our members.
